Commission Minutes 2/20/2024

Now on this 20th day of February 2024, the Board of Commissioners, Sheridan County, Kansas met in regular session with Chairman Mike "Buck" Mader presiding. Other members present were Joe Bainter, David Stithem, Joe Pratt, County Attorney, and County Clerk, Heather Bracht. At 8:00 a.m. Mader called the

meeting to order.

Those in attendance stood and recited the Pledge of Allegiance.

Joe Herskowitz, Road & Bridge Supervisor, came to the table with Scott Foote entering shortly after. Foote was present to discuss the road project on Sheridan Ave. at 9th St. to Road 10W. Foote would like Road 10W from the Catholic Cemetery south to his home to be included when bids are let for the work to be done. Last estimate from Hwy 24 at 10W to the Catholic Cemetery was \$538,800 and from the Catholic cemetery south to his home \$359,200. Foote stated he would pay 100% of the cost from the cemetery to his home. The Board advised Foote that the County does not have the funds to pave the road north. Once the information has been put out that the County is accepting bids and a cost is given, Foote will make contact with the landowners north of the Catholic Cemetery and see if there is any interest in others contributing to pay for the road work. Striping on the road was discussed. Everyone agreed that striping increases safety. Herskowitz will advise Penco Engineering to submit the application for the Cost Share Program. If awarded, it would entail a 15% match from the County on whatever project is done. Herskowitz spoke with Jef Stewart, KDOT, about the Hwy. 23 project. KDOT is still trying to get the rights-of-way purchased.

The repaired equipment is back from North Platte. Graders are running. There was a brief discussion on roads. Herskowitz has been

contacted by Dusty Bell at PSI about the need for a recycling trailer. Bids were received from Better Built Trailers for the recycling trailer and the prices have increased since the last time any were purchased. For now, a wire box will go out and will just be emptied daily. A tarp will be used to cover the trailer in case of bad weather. The hospital is coming to the commissioner meeting next week and there will be a talk about the remaining recycling trailer there, whether the hospital still needs it or not.

to approve the purchase of the recording system including the maintenance program. Bainter seconded. Carried 3-0

Stithem made a motion to approve the Treasurer Abatements as presented. Mader seconded. Carried 3-0

The Resolution pertaining to EMT stipend and run pay was approved on a motion by Stithem and second by Bainter. Carried 3-0

Mader advised the Board he had sold the two vehicles that the county had been looking at for the Appraiser's Office but was getting two more this week.

The Employee Handbook will be updated and ready for approval at the next meeting.

On a motion from Mader and second from Bainter the February 13, 2024 Minutes were approved as amended. Carried 3-0

The Board briefly discussed roads and future plans.

At 9:22 a.m. with no further business, Bainter made a motion to adjourn, seconded by Stithem. Carried 3-0. The next regular meeting will be Tuesday, February 27, 2024, at 8:00 a.m. in the Commissioner's Room.

Kansas Crop Values

Manhattan - The value of Kansas's 2023 field and miscellaneous crops is forecast at \$7.76 billion, according to the USDA's National Agricultural Statistics Service. This is down 17% from 2022.

The value of **corn** production is expected to total \$3.00 billion, down 16% from the previous marketing year. Kansas's corn price is projected to average \$4.90 per bushel, down \$2.14 from the last marketing year.

The value of **soybean** production is expected to total \$1.32 billion, down 29% from the previous marketing year. Kansas's soybean price is projected to average \$12.60 per bushel, down \$1.70 from the last marketing year.

Pertaining to the bridge at 50W/110-120S Herskowitz states the best thing to do is scrape off the top and then replace whatever needs it. The Cressler/Pratt bridge will be started on this week. Machines will be put across the road and keys pulled to keep people off the road. There was discussion about the use of gravel vs. shale. The Board and Herskowitz discussed gravel pits.

Dana Hess, Communications, came to the table requesting to purchase new recording equipment for two of the phones, as well as the annual maintenance on the equipment. Total cost is \$4,029. This can be paid for out of E911 funds. Stithem made a motion The value of **winter wheat** production is expected to total \$1.51 billion, down 29% from the previous marketing year. Kansas's winter wheat price is projected to average \$7.50 per bushel, down \$1.21 from the last marketing year.

The value of **sorghum** production is expected to total \$819 million, up 13% from the previous marketing year. Kansas's sorghum price is projected to average \$8.65 per cwt, down \$3.65 from the last marketing year.

The value of **cotton** production is expected to total \$51.9 million, down 25% from the previous marketing year. Kansas's cotton price is projected to average \$0.64 per pound, down \$0.22 from the last marketing year.

The value of **alfalfa** production is expected to total \$574 million, up 14% from the previous marketing year. Kansas's alfalfa price is projected to average \$256.00 per ton, up \$11.00 from the last marketing year.

The value of **other hay** production is expected to total \$453 million, up % from the previous marketing year. Kansas's alfalfa price is projected to average \$163.00 per ton, up \$24.00 from the last marketing year.
