eligible producers who incurred losses due to natural disasters in 2020 and 2021.

This is a direct result of our ongoing work with USDA officials to address concerns about the misguided changes to the ERP program after the successful and widely praised rollout of ERP phase one.

At a time when the USDA should have been focusing on meeting the needs of the farmers and ranchers impacted by natural disasters, it instead made fundamental and problematic changes to an otherwise effective program. These changes in no way reflected congressional intent of the program and have created major delays in getting farmers the assistance they needed. The recent changes to the ERP program unfairly discriminate against full-time farm families who suffer the deepest losses. While we are too far down the road to undo the USDA's misguided alterations to this program, we were able to get financial help for our farmers through additional payments under the successful ERP Phase One with unused funds allocated to 2020 and 2021 natural disasters.



Now on this 6th day of February 2024, the Board of Commissioners, Sheridan County, Kansas met in regular session with Chairman Mike "Buck" Mader presiding. Other members present were Joe Bainter, David Stithem, Joe Pratt, County Attorney, and County Clerk, Heather Bracht.

At 8:00 a.m. Mader called the

meeting to order.

Those in attendance stood and recited the Pledge of Allegiance.

Joe Herskowitz, Road & Bridge Supervisor, came to the table. Herskowitz advised the Board that the CAT road maintenance class has been scheduled for February 21 & 22, weather permitting. This will be for six of the newer guys. A refresher class will be scheduled later for everyone else.

The grant project for the commercial can crusher ends February 14, 2024. The County will pay the balance for the unit and then will be reimbursed. The crusher will be kept at recycling and will crush cans and aluminum, which will be baled. The motor in the blade has been taken out and the blade will need to have the motor overhauled or a new motor. This is the unit that is in North Platte, NE. After discussion, Mader made a motion to approve the new motor at a cost of \$68,418 which includes a three-year warranty. Bainter seconded the motion. Carried 3-0

There was a brief discussion about rotating of graders. The Board discussed repairs that need to be made on some of the machines. Herskowitz will bring information pertaining to extending warranties on some of the equipment.

On a motion by Stithem and second by Mader, approval was given to purchase a new printer/fax machine for the Road & Bridge Department at a cost of \$599 through Quill. Carried 3-0. Herskowitz was advised to see if there is a government program out there or a trade-in allowance.

Herskowitz advised the Board that a road which had been worked recently at 90S/100-130W had the bottom fall out. The individual who had worked the road will go back and redo what is needed as soon as it dries out. Road & bridge crews went out and just pushed the mud out of the road. Herskowitz stated he reminded the guys that they need to check roads after storms. The roads aren't done until the next storm. There was more

Mader made a motion to approve the January 30, 2024 Minutes as presented. Stithem seconded. Carried 3-0

At 9:23 Mader made a motion to enter into executive session for a period of 30 minutes for the discussion of non-elected personnel. Bainter seconded. Carried 3-0. Present were the Board, Bracht and Pratt. The door opened at 9:53 and Mader made a motion to extend the executive session for a period of 20 minutes. Bainter seconded. Carried 3-0. The door opened at 10:13 with no decision being made. Courthouse department heads will be asked to come to the February 13, 2024 meeting.

At 10:13 a.m. with no further business, Mader made a motion to adjourn, seconded by Bainter. Carried 3-0. The next regular meeting will be Tuesday, February 13, 2024 at 8:00 a.m. in the commissioner room.
