Another Massive Spending Bill: The Budget Process is Broken

Now on this 12th day of March 2024, the Board of Commissioners, Sheridan County, Kansas, met in regular session with Chairman Mike "Buck" Mader presiding. Other members present were Joe Bainter, David Stithem, Joe Pratt, County Attorney and County Clerk, Heather Bracht. Guest was The Sheridan Sentinel.

At 8:00 a.m. Mader called the meeting to order.

Those in attendance stood and recited the Pledge of Allegiance.

Joe Herskowitz, Road & Bridge Supervisor, and Evan Turley, Noxious Weed Director, came to the table. Turley presented the State Contract for treatment of noxious weeds. After discussion, by consensus the contract was approved and signed by the Board.

A magnet was used last week on a road. By consensus, the Board approved purchasing two more at a cost of \$475/each.

The can crusher showed up on Monday. Meyer Electric will come sometime this week and put a cord in.

The crack in the girder on the "Cressler" bridge was found. Herskowitz stated they will splice it together with a piece of steel and bolt it.

The Cost Share application was submitted for use on the "Y" east of Selden.

Pat Haffner has offered some "superior" fill dirt to be used on the roads in Tasco but wants the problem areas by his home fixed first. The Board asked Herskowitz to check the bridge at Paul Haffner's home the end could be plugged.

There was a brief discussion about the south Hwy 23 project and various other roads.

At 8:38 Mader made a motion to enter into executive session for a period of 10 minutes for the discussion of non-elected personnel. Stithem seconded. Carried 3-0. "As the local law enforcement says, we're not going to arrest ourselves out of this problem. There's not enough law enforcement officers to arrest the people. We have to secure the border."



had more new mothers seeking postpartem care, and that kids in Medicaid recipient families were more likely to access health care.

"Obamacare" benefits for Medicare expansion provide 90 percent of costs to come from taxpayers federal payments, while state tax payers pay the remaining 10 percent. Clancy said Kansas needs a health care system that puts patients in charge, not third-party payors.

"The biggest problem we face, the root problem, is that In America the patient is not the customer, the patient is the product," Clancy testified. "This is because 90 percent of health care is paid for by strangers — third parties like health insurance companies, businesses, and government programs — rather than directly by patients. The good news is that, with incremental free-market reforms, we can put the patient in the driver's seat. We can make our system the best and most affordable in the world instead of merely the most expensive."

Hearings were set today to explore a version of the bill in the House or Representatives.

UPDATE: This bill was not referred from committee for action after the hearing.
